## ORDINANCE NO. 12

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF IVANHOE TO ILLUS CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ITTING UPON THE CITY LIMITS.

WMEREAS, a certain petition dated February 21, 1978, requesting annexation the territory hereinafter described was duly presented to the council on the th day of February, 1978; and

WHEREAS, the quantity of land embraced within the area described in the petition d bounded as described is 6.11 acres of unplatted land, no part of which is included thin the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by the sole owner of the territory described alow, and

WHEREAS, no objections to the annexation have been received from the town board, he county board, or the governing body of any municipality whose boundaries abut bon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the City limits at the outh boundary thereof;

The Council of the City of Ivanhoe, Minnesota ordains:

Section 1. The City Council hereby determines (1) that the annaxation will be to the best interests of the city and of the territory affected (2) that the territory described herein abuts upon the city limits and is urban or suburban in character and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

A parcel of land located in the Mest Half of the Northwest Quarter of Section 2, Township 111 North, Range 45 Mest, Ash Lake Township, Lincoln County, Minnesota, being more particularly described as follows:
Commancing at the northwest corner of the West Half of the Northwest Quarter of said Section; thence South, assumed bearing, along the west line of the West Half of the Northwest Quarter of said section, a distance of 1110.00 feet to the southwest corner of the recorded plat of SPANTON'S FIRST ADDITION, IVANHOE, MINNESOTA, said point also being the Point of Beginning of this description; thence North 89 degrees 40 minutes 00 seconds East, along the south line of said plat and parallel with the north line of the West Half of the Northwest Quarter of said section, a distance of 403.00 feet; thence South, parallel with the West line of the West Half of the Morthwest Quarter of said Section, a distance of 650.00 feet; thence South 89 degrees 40 minutes 00 seconds West,

parallel with the south line of said plat and the north line of the West Half of the Northwest Quarter of said Section, a distance of 403.00 feet; thence North, along the west line of the West Half of the Northwest Quarter of said Section, a distance of 660.00 feet to the Point of Beginning. Said parcel contains 6.11 acres of land, more or less, and is subject to existing easements of record.

Section 3. Filing. The City clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the County Auditor and the Town Clerk of Ash Lake Township.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
